SOLE SOURCING OSC EDGETECH FOR FEDERAL ACQUISITIONS



For 8(a)-certified Alaska Native Corporations (ANCs) like OSC EdgeTech, a Justification and Approval (J&A) is not required for sole source awards under \$100 million for the Department of Defense and under \$25 million for civilian agencies. A J&A is a formal document that outlines the statutory authority, rationale, and supporting justification for awarding a contract without full and open competition. Under SBA regulations (FAR 19.805-1(a)(2)), the 8(a) sole source contracting method allows Federal agencies to engage in direct negotiations with eligible 8(a) firms such as OSC EdgeTech, even in cases where two or more qualified 8(a) firms could perform the work. This provision makes the 8(a) program the only federal small business program that permits sole source awards under these specific conditions, offering agencies a streamlined and legally supported pathway to meet mission requirements efficiently.

PROCESS BENEFITS

The 8(a) Sole Source Vehicle provides agencies a simplified and shortened acquisition procedure:

- Reduced acquisition cycle, measured in days
- Lowered administrative costs
- Initiate contract with a high-level statement of work
- Directly negotiated best value pricing
- Credit for small business promotion within the agency

IF YOU ARE AN END USER: Submit items 1-3 together to the Contracting Officer at the same time.

1. Contact the Contracting Officer (CO) by email or letter requesting the procurement be awarded as an 8(a) sole source to OSC EdgeTech. A J&A is not required per FAR 6.302-5(c)(2)(iii) if the award is under \$4.5M, or under \$100M for DoD / \$25M for civilian agencies when awarding to an ANC.
2. Include OSC EdgeTech's capabilities statement.

4. Separately, email Ms. Gonzalez with the CO's name, email, phone number, and PR number (if available). She will confirm OSC EdgeTech's eligibility and respond directly to the CO.

IF YOU ARE A CONTRACTING OFFICER:

1. Draft an offer letter to Ms. Irene Gonzalez, the SBA Business Opportunity Specialist assigned to OSC EdgeTech, formally offering the requirement to the 8(a) program. Once the SBA approves the offer letter, an acceptance letter will be sent back to you confirming the award may proceed under the 8(a) program.
2. Upon SBA acceptance, you may begin negotiations directly with OSC EdgeTech. Pricing, terms, and validation of the requirement are addressed during this phase.
3. Finalize the award by completing a Standard Form 1449 (SF1449) to issue the contract to OSC EdgeTech under the 8(a) Sole Source authority. If you need assistance drafting the offer letter or completing the SF1449, please contact Ms. Gonzalez (see contact information above).
